Hi Elizabeth,

You submitted a change request:

One additional request. In the current format, all indicators (semi-annual and quarterly) are in one report. Would it be possible to split these into two reports—one for quarterly and one for semi-annual indicators? While we can run the full report twice (once for each period), this may lead to errors if the wrong version of a particular indicator is mistakenly used. Having a specific report for each time period would minimize potential errors and would still allow partners to run the queries for a different period if they would like to do that.

Can you tell me which indicators you would like in the semi- annual report and which in the quarterly report? I am logging it as a change request and need additional information.
