



TERMS OF REFERENCE: TECHNICAL WORKSHOP POC, EPTS & HELPDESK

1. BACKGROUND

As part of the PEPFAR HIS Strategy changes, Jembi was indicated as the new HIS implementing partner from October 1st, and will be responsible for:

- Supporting OpenMRS EPTS development
- Supporting OpenMRS POC Re-engineering
- Supporting OpenMRS platform and architecture selection (PEPFAR, IPs)
- Supporting OpenMRS reports (query) development
- Continue to support OpenMRS deployment
- Helpdesk for all HIS related activities will transition to JEMBI

In order to start interacting with partners and to better understand the current status and challenges, Jembi HS in collaboration with CDC intends to conduct a workshop with all implementing partners to share relevant information on the entire project, confirm the scope and basic requirements and establish joint EPTS support plan and coordination mechanisms.
